

**THE TUESDAY MORNING #TreasuredGift SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES ENTRY PERIOD: The Tuesday Morning #TreasuredGift Sweepstakes (the “Sweepstakes”) begins at 12:00:01 AM Central Time (“CT”) on Tuesday, November 3, 2015 and ends at 11:59:59 PM CT on Monday, November 30, 2015 (the “Sweepstakes Period”). There are four (4) Entry Periods as defined the chart below (the “Entry Periods”). Tuesday Morning, Inc.’s (the “Sponsor”) clock will be the official timekeeping device for this Sweepstakes. Entries must be received according to the chart below to be eligible for that Entry Period drawing. Non-winning entries will not be carried over to subsequent Entry Periods.

ELIGIBILITY: The Sweepstakes is open to legal residents of the 48 contiguous United States, and the District of Columbia, age 18 or older at the time of entry. Void outside the U.S., and wherever else prohibited by law. Employees of Sponsor and its respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

ENTRY: Sponsor will pose one (1) question during each Entry Period as shown in the chart below (the “Weekly Question”). Entrant must respond to the Weekly Question posed by Sponsor for the corresponding Entry Period using one of the methods of entry below.

There are three (3) ways to enter.

Method #1: Facebook Entry. To enter on Facebook:

- 1) Visit www.facebook.com/TuesdayAM, locate the post in the Tuesday Morning timeline from Tuesday Morning which includes the Weekly Question for the current Entry Period (the “Sweepstakes Posts”);
- 2) Submit a comment to the current Entry Period’s Sweepstakes Post with a response to the question posed (the “Entry Comment”) no later than the end of the current Entry Period to receive one (1) Facebook entry (the “Facebook Entry”) for the Entry Period.

Method #2: Instagram Entry. To enter on Instagram:

- 1) Log in to your Instagram account and follow @TuesdayMorning on Instagram,
- 2) Upload and share a photo in response to the current Entry Period's Weekly Question, including the hashtag #TreasuredGift and #Sweepstakes and tagging @TuesdayMorning in the photo caption (the "Instagram Entry").

Message & data rates may apply. Any post that includes the hashtags '#TreasuredGift' and '#Sweepstakes' that is posted prior to the start of or after the end of the Entry Period will not be eligible for the Sweepstakes.

Entrant's Instagram settings must be public. Entries uploaded from private Instagram accounts will not be eligible. Entrants must follow and continue to follow @TuesdayMorning through at least December 31, 2015 in order to be notified in the event he/she is a potential winner. Instagram is free to download and available for iPhone from the Apple App Store and for Android from the Google Play Store.

Method #3: Twitter Entry. To enter on Twitter:

- 1) Follow Tuesday Morning on Twitter at <http://twitter.com/TuesdayMorning> (@TuesdayMorning);
- 2) Post a Tweet that includes '@TuesdayMorning', the hashtags '#TreasuredGift' and '#Sweepstakes', and a response to the current Entry Period's Weekly Question (the "Twitter Entry"). Twitter Entry may include a photo but is not required.

Message & data rates may apply. Any Tweet that includes the hashtags 'TreasuredGifts' and '#Sweepstakes' that is posted prior to the start of or after the end of the Entry Period will not be eligible for the Sweepstakes. If a Tweet is more than one post in length it will be considered as one entry with the first post considered the entry.

Entrant's Twitter setting must be public. Tweets from private Twitter accounts will not be eligible. The decisions of Sponsor are final and binding on all matters relating to determining eligibility of Tweets. Entrant must continue to follow @TuesdayMorning through December 31, 2015 in order to be notified in the event he/she is a potential winner. By submitting a Twitter Entry, Entrants agree to [Twitter's Terms of Service](#). Twitter, Inc is not a sponsor of this sweepstakes.

Entries must be received during the Entry Period to be eligible for that Entry Period's drawing. Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy.

IMPORTANT: Message and data rates may apply to use of mobile phone/device to participate in Sweepstakes.

All methods of entry have an equal chance to winning. All entries become the property of the Sponsor and will not be acknowledged or returned.

Limit: One (1) entry per person during each Entry Period.

ENTRY REQUIREMENTS: All Facebook, Instagram, and Twitter entries (collectively referred to as "Entry") must comply with the following minimum guidelines to be eligible:

- Once a photo has been submitted, it cannot be modified by Entrant;

- Photo must be original;
- No duplicate photos may be submitted;

By submitting an Entry, Entrant warrants and represents that: (a) photo does not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other legal or moral rights of any person or entity; (b) Entrant has obtained written permission from a third party whose photograph is being used in the Entry; (c) Entrant owns all rights to the Entry, including without limitation, copyrights, and has received prior written permission from a third party if any photo was photographed by someone other than the Entrant him/herself; (d) publication of the Entry via various media, including posting on the Sponsor's websites, will not infringe on any third-party rights; and (e) Entrant will indemnify and hold harmless the Sponsor and related entities, agents and assigns from any claims and damages (including reasonable attorneys' fees) arising from or relating to the breach or alleged breach of your representations and warranties herein, the Entry, or Entrant's conduct in creating the Entry, the acceptance or use of any prize or otherwise in connection with this Sweepstakes.

WINNER NOTIFICATION: Potential Grand Prize winners will be notified via reply to the Entry Comment originally posted by Entrant. Potential winner will be asked to send a private message to the Sponsor with his/her name and email address within twenty-four (24) hours. Once provided, the potential winner will be notified by email and will be required to provide their mailing address within two (2) days via return email. Noncompliance will result in disqualification and an alternate winner may be selected. Prize will be sent within 4-6 weeks of winner being verified.
